Founded in response to the 2008 Economic Recession, our organization has empowered countless individuals to overcome financial crises and achieve lasting financial freedom through education, direct services, and strategic referral partnerships.

We understand the immense challenges faced by Low- and Moderate-Income (LMI) households in our region, as they navigate rising rents, mounting debts, and economic uncertainty. These pressures

have pushed many to the brink, but with proper support, we can help them reclaim stability and build a brighter financial future.

Thus, our mission is to provide a comprehensive, integrated approach that combines financial education, housing support, and access to critical financial services. By equipping Low- and Moderate-Income individuals and families with the tools they need to achieve economic inclusion and financial security, we aim to break the cycle of poverty, prevent homelessness, and empower people to thrive. Service Area

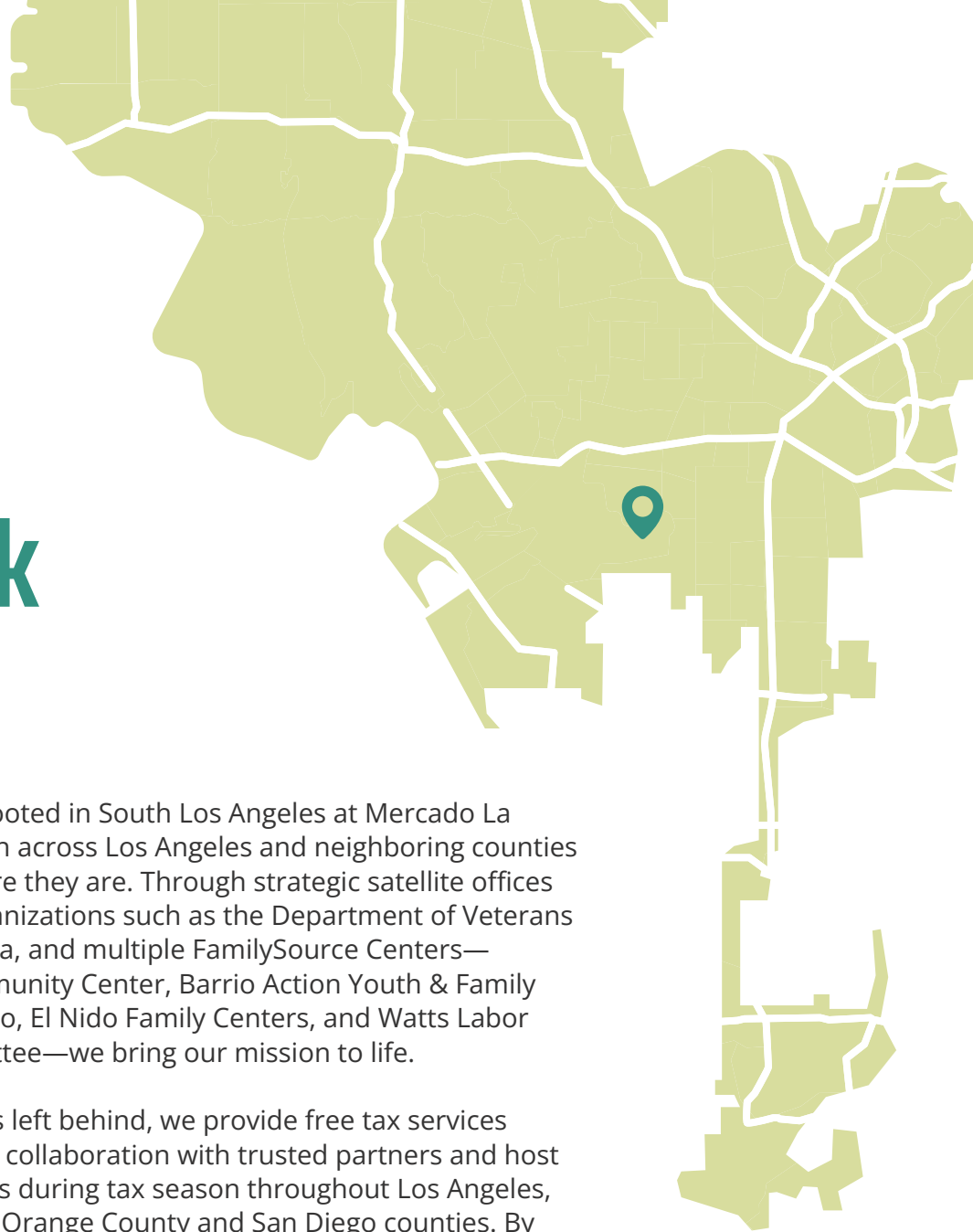
Haven Services is deeply rooted in South Los Angeles at Mercado La Paloma, extending its reach across Los Angeles and neighboring counties to meet communities where they are. Through strategic satellite offices and partnerships with organizations such as the Department of Veterans Affairs, City of Santa Monica, and multiple FamilySource Centers—including All Peoples Community Center, Barrio Action Youth & Family Center, El Centro del Pueblo, El Nido Family Centers, and Watts Labor Community Action Committee—we bring our mission to life.

To ensure no community is left behind, we provide free tax services and financial workshops in collaboration with trusted partners and host numerous pop-up locations during tax season throughout Los Angeles, Riverside, San Bernardino, Orange County and San Diego counties. By breaking barriers to access, we empower individuals and families with the tools and support needed to achieve financial stability and independence.

Service Population

We are dedicated to uplifting 100% Low- and Moderate-Income (LMI) individuals and families through no-cost financial education workshops and direct services.

Our impact spans a diverse range of vulnerable populations, including At-Risk Youth, Domestic Violence Survivors, Justice-Involved Individuals, LGBTQ+ members, Seniors, Transitional Age Youth (TAY), Undocumented Immigrants, U.S. Military Veterans, and more. By addressing the unique challenges of each group, we empower individuals to overcome barriers, achieve financial stability, and thrive.

Daveion McClanaham, a 32-year-old resident of Santa Monica, faced significant financial challenges due to past credit issues and the absence of a bank account. With no established credit score and limited financial literacy, he sought assistance in building a stable financial foundation.

Through a community outreach event focused on financial literacy, Daveion was introduced to Haven Services, where he engaged with Financial Coach, Angel Morales. Under Angel's guidance, Daveion participated in personalized credit counseling sessions and received tailored financial education aimed at addressing his credit concerns and improving his financial management skills.

As part of this initiative, Daveion successfully enrolled in the SAVE2BUILD credit-building program and opened a checking account to strengthen his financial capabilities. Throughout the program, he received continued support in managing his finances, setting up a savings plan, and developing responsible credit habits.

Upon completing the SAVE2BUILD program, Daveion achieved substantial financial progress. A credit report retrieved from his Experian account confirmed a 200-point increase in his credit score, reaching 720. Additionally, through structured savings efforts within the program, he accumulated an extra \$600 in savings.

With the successful conclusion of the SAVE2BUILD program, Daveion is currently in the process of applying for credit cards to further establish his credit history. Additionally, he is exploring options to open a High-Yield Savings Account (HYSA) to support his long-term financial goal of saving \$5,000 this year.

Moving forward, Haven Services will continue to support Daveion through ongoing financial planning, goal setting, and credit management strategies to ensure his continued financial stability and long-term success.

Program Overview

Free 1:1 Financial & HUD-Approved Housing Counseling

Haven Services offers personalized certified counseling services to address both financial and housing challenges. Our certified counselors assist clients in managing debt, improving credit scores, and navigating the complexities of homeownership or Tenant's Rights. Free Tax Preparation Services - File4Free

Through the IRS Volunteer Income Tax Assistance (VITA) program, we offer no-cost tax preparation and ITIN application services to low- and moderate-income individuals and families. Our certified trained staff and volunteers ensure accurate and timely filing, helping clients maximize refunds and access credits such as the Earned Income Tax Credit (EITC). This service not only increases annual income but also serves as an additional financial capability and housing services.





Partnership Program

The Partnership Program (Partnership) is a regional initiative created and led by Haven Services—one of Southern California’s leading nonprofits in financial capability and housing counseling. Our mission has always been rooted in meeting people where they are, through a three-pronged approach of education, 1:1 counseling, and support services. As a trusted community-based organization for over 15 years, we have witnessed firsthand the transformative power of collaborative action in addressing the structural barriers faced by vulnerable populations.

Yet, as service providers, we also saw the challenges: nonprofits working in silos, duplication of efforts, missed funding opportunities, and barriers to authentic collaboration. The nonprofit ecosystem in Southern California—especially for small to mid-sized organizations—is both

vibrant and fragmented. Partnership was created to bridge that gap.

Initially launched as a one-day event in 2024, the Partnership.LA Summit was conceived with one core purpose: to connect small, community-focused organizations with the institutions that hold power, influence, and resources—corporate partners, philanthropic foundations, and government agencies. The event exceeded expectations, sparking powerful collaborations and surfacing a clear, unmet demand for ongoing connection.

Today, Partnership has grown into a year-round initiative that centers equity, access, and sustainability in three key areas: annual regional summits, year-round resource mobilization & development, and curated networking and collaboration opportunities.



Achievements & Highlights 2025

- **Provided critical support during the wildfires**, mobilizing resources and assistance to help impacted families stabilize and recover.
- **Received a grant from Capital One** to address the urgent needs of wildfire victims in Los Angeles, further enhancing our disaster response efforts.
- **Celebrated with the FDIC during the CalMoneySmart ceremony** and received a **Certificate of Recognition at the CalMoney event**, highlighting our leadership in financial education and empowerment.
- **Honored with an award from Rise Economy**, recognizing our impact in advancing economic justice and opportunity.
- **Hosted the Financial Freedom Fair**, bringing together community members, partners, and resources to promote financial wellness.
- **Convened the 2nd Annual Partnership.LA Summit and launched the Partnership Program's new platform, FindPartnership.org**, strengthening collaboration and expanding access to services.
- **Secured the CALEITC Grant**, expanding our capacity to connect eligible families with valuable state tax credits.
- **Received the LITC Grant**, strengthening our ability to provide low-income taxpayers with education and representation services.
- **Renewed our IRS VITA grant for the third consecutive year**, reaffirming our commitment to delivering high-quality, free tax preparation services to the community.
- **Partnered with the City of Santa Monica to distribute over \$300,000 in emergency aid funding** to residents, ensuring timely financial relief for those in need.
- **Launched the Santa Monica for All Campaign on November 19th** in response to multiple ICE raids targeting workers in the city, demonstrating our commitment to protecting and supporting vulnerable community members.
- **Launched the File4Free program** and participated in our fifth consecutive year as a VITA tax preparation agency in Southern California, increasing access to free and trusted tax services.
- **Unveiled our new brand, Haven 2.0**, introducing an updated look and feel that reflects our growth and renewed vision for the future.
- **Francisco Valenzuela, our VITA Compliance Manager & LITC Clinic Director presented at Prosperity in Washington, D.C.**, sharing our model and impact on a national stage.

Success Story



Elizabeth Martinez, a dedicated mother of two young girls, has been a longstanding resident of the El Sereno community. As a head of household, she has always been resourceful in managing her family's finances. Before the COVID-19 pandemic disrupted services, she utilized the tax preparation services through Haven Services at Barrio Action. However, the temporary pause in services during the pandemic led her to seek assistance from a paid tax preparer.

While the paid preparer initially met her needs, Elizabeth found the costs to be increasingly burdensome. Recognizing the need to allocate her resources wisely, she decided to return to Barrio Action for tax preparation services this year. The high cost of the paid preparer was taking too much of her tax refund, which she relied on to cover essential bills and expenses.

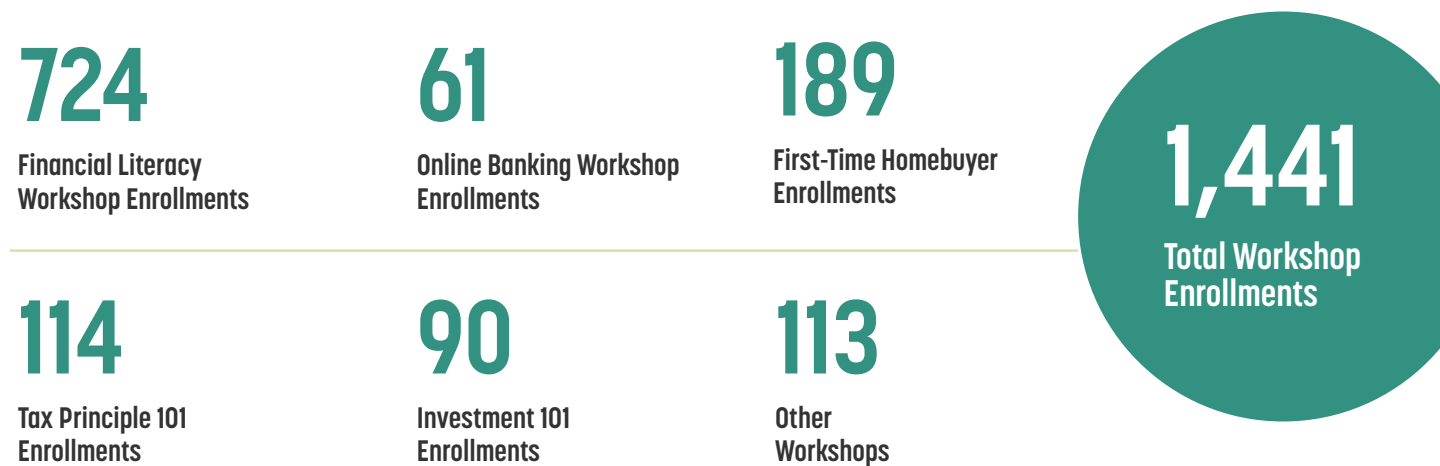
Upon returning to Barrio Action, Elizabeth was surprised to be reminded of the array of services available to her through the organization. The experience reaffirmed her decision to return and solidified her commitment to utilizing Barrio Action for her future tax preparation needs. She expressed gratitude for the invaluable service provided and expressed intent to continue utilizing services in the future.

With a tax refund of \$12,639, Elizabeth has ambitious plans for her family's future. She intends to save the money, with the hope of purchasing a home for her family someday. These refunds often serve as a lifeline, boosting annual income and enabling families to save for a brighter future.
